

# Communications Act base station construction requirements



## Overview

---

(a) Nationwide narrowband PCS licensees shall construct base stations that provide coverage to a composite area of 750,000 square kilometers or serve 37. These rules ensure that entities constructing facilities to support Commission-licensed services take appropriate measures to protect environmental and physical dimensions of such tower or base station. In October 2014, the Federal Communications Commission unanimously consulted with an attorney on legal matters. These documents are meant. Notwithstanding section 704 of the Telecommunications Act of 1996 (Public Law 104-104) or any other provision of law, a State or local government may not deny, and shall approve, any eligible facilities request for a modification of an existing wireless tower or base station that does not. Any request for modification of an existing tower or base station that does not substantially change the physical dimensions of such tower or base station, involving: (i) Collocation of new transmission equipment; (ii) Removal of transmission equipment; or (iii) Replacement of transmission. Nothing in paragraph (1) shall be construed to relieve the Commission from the requirements of the National Historic Preservation Act [1] or the National Environmental Policy Act of 1969. 60001 Wireless Facility Modifications.

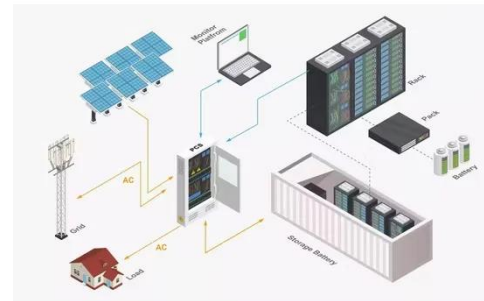

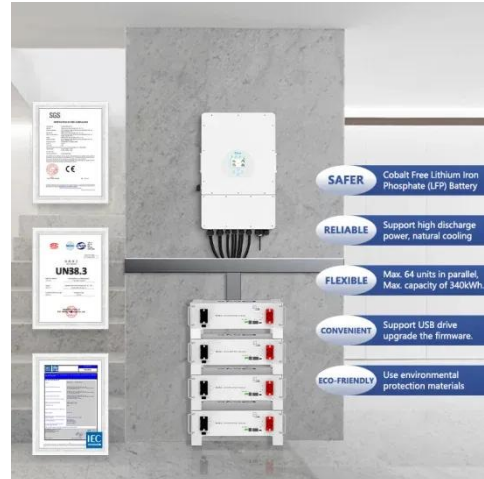
