Overview

Issues often involve intricate analysis of power electronics (inverters), grid interaction, power quality, fault behavior.

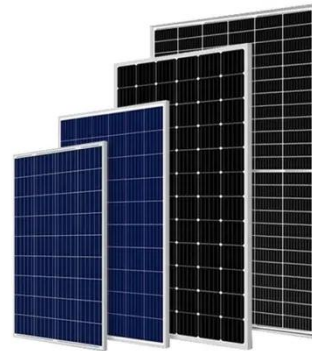

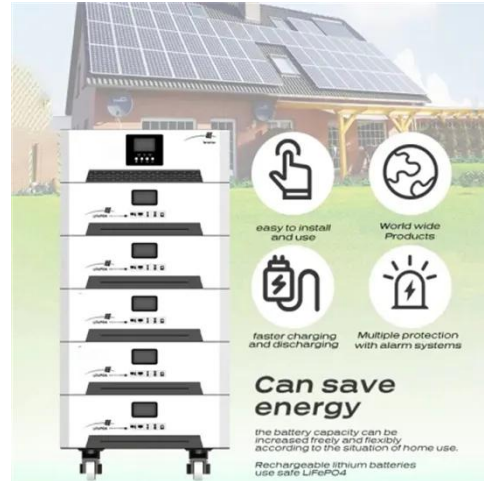
